Participation requires the approval of the Alberta Gaming & Liquor Commission and is subject to any conditions imposed as part of the approval.

- No sampling will be permitted unless authorized by Mayfield Inn & Suites
- Request must be received in writing minimum 3 weeks prior to event
- Request must detail product being sampled
- Maximum sample sizes are as follows:
 - Beer 113 ML (4 oz.) Spirits 14 ML (1/2 oz.)
 - Coolers 13 ML (4 oz.) Liqueurs 14 ML (1/2 oz.)
 - Wine 56 ML (2 oz.)
